Hate Crime Reporting -

The new year begins with police service contact meetings as we begin to analyze the data from survey and community forums. The police meetings serve two main purposes, one is to establish understanding of project status and police service policy around hate crime in 2022. The other reason is to best position the data and subsequent recommendations for police services in line with project goals. All meetings will culminate with sharing the data set and will collaborate with police services for actional next steps (i.e. training, policy brief, event, etc.) January is a time to huddle up and reflect on the journey while analyzing and making sense of the data collected. lakhdeep@cassa.on.ca

Equity in Education Project -

1. The Equity in Education project has completed recruiting for Volunteer Cohort 2, and have been onboarding our new volunteers. Volunteers have the following trainings coming up:

- Introduction to Advocacy: a workshop designed to familiarize student & parent volunteers with the Ontario school board systems, governance structures, and bureaucratic methods of making change in the education system.
- Anti-Islamophobia 1-on-1 Workshop: a workshop done by CCMW's Dare To Be Aware program, to educate students on how Islamophobia presents itself in Canadian society.

 Leadership & Action Planning Workshop: Harmony Movement's action-planning workshop is designed to develop advocacy and leadership skills, while teaching students how to form concrete action plans to establish change in the community.

2. The Equity in Education project is still looking to **recruit Muslim parents of students** to take part in **volunteer training**! If you are a Muslim parent of a student interested in making change in the Ontario education system, please register <u>here</u>.

3. The Peel District School Board is currently working on an Anti-Islamophobia strategy to implement board-wide, including mandatory Islamophobia training, parent & community involvement, and enhanced accountability frameworks. CASSA is working with Peel Parent Involvement Committee and the Peel Board, as well as various community organizations, to comprise a comprehensive strategy that will make the education system more inclusive for Muslim students and parents.

According to <u>the National Survey on Online Hate Speech and Racism in Canada</u>, 1 in 5 Canadians have experienced some form of online hate. In collaboration with the Anti-Hate Community Leaders' Group, the Council of Agencies Serving South Asians (<u>CASSA</u>) has launched a social media campaign, #EradicateHate, to raise awareness around the pervasive issue of online hate. do not consider their specific needs and circumstances.

While Canada has committed to the right to housing, it has not adopted the broad definition of homelessness that has recently been recognized by the United Nations. The government has instead relied on a narrow definition of "chronic homelessness" when implementing programs that address homelessness under its National Housing Strategy (NHS). **This narrow definition excludes hidden homelessness which is the most common way women and gender-diverse people experience homelessness.**

The Centre for Equality Rights in Accommodation (CERA) has recently launched a petition calling on the federal government to change its definition of homeless to include the experiences of women and gender-diverse people.



The Ministry of Health is committed to providing all Ontarians with access to health information and advice to meet their individual needs. This includes assessing eligibility for certain health care services and helping people to get connected to local health services and other supports available across the province to guide them through their health care journey.

The Health Care Navigation Service will make it possible for people in Ontario to connect to health and social services through the internet or through a telephone service. This service is envisioned to be the "front door" to accessing health information and related health care services.

We need your help to do this work!

We are looking for 20-25 Ontarians of diverse backgrounds, experiences, and ages to join a new advisory group to help guide this work. You will be asked to test and review new websites, applications, and share your opinions and experiences. Your feedback will help us to develop a product that meets the needs, wants and expectations of people across Ontario.



Ontario's top doctor stresses COVID vaccines for children 5 to 11 are safe, effective

Ontario's top doctor is stressing that COVID-19 vaccines for children aged five to 11 are safe and effective against the virus.

"I want to be clear that the pediatric Pfizer vaccine for children five to 11 is safe, effective, and provides strong protection against COVID-19 and variants," Moore's statement said. Speaking at a Toronto vaccine clinic, he encouraged parents to quickly send back consent forms for in-school vaccination clinics so Ontario can quickly get more kids protected against the virus.

Internationally educated nurses to be deployed to Ontario hospitals and long-term care homes

Ontario will be relying on internationally educated nurses to help fill staff shortages in hospitals and other health care settings. Health Minister Christine Elliott made the announcement at a press briefing on health capacity Tuesday afternoon.

According to Elliott, international nurses who have applied to practice in Ontario will have the opportunity to meet their application requirements by working in health-care settings "under the supervision of a regulated health-care provider". Matching with health-care providers is expected to begin later this week, with onboarding new staff in the weeks ahead. <u>Read more here.</u>

landfill by recycling them. For Eric Ethier, Go Zero Recycle president, it doesn't make sense for the masks to be thrown out when they are "100 per cent recyclable." COVID-19: Omicron peak could be soon, some estimates show

Furness noted that modelling data in December showed that the peak of this wave was expected to hit mid-January. With this in mind, Furness said Canada is likely close to reaching the peak of the Omicron wave. However, he said it is important to remember that models are just estimates. " [Models] can only reflect the limited understanding you have in the first place to sort of protect what might be the case," he said. "I'm guessing that we're probably just about to peak in most places in Canada in the next week, two weeks, maybe a little bit longer than that." <u>Click here to read more.</u>
